

The City of Bend invites Sealed Bids for construction of the Pinehaven-Woodhaven Sewer Project (1SN05). The project consists of construction of new gravity sewer and laterals through areas primarily served by private septic systems. The scope of work includes, but is not limited to, trenching and installation of approximately 1,441 LF of 8-inch gravity sewer pipeline at depths approximately 3 - 12 feet, sewer manholes, gravity sewer services, temporary traffic control, street reconstruction, and general right of way restoration. The Engineer's estimate is between \$902,673 and \$1,153,415.
